

**RESOLUTION SETTING FORTH FINANCIAL REQUIREMENTS  
OF THE  
BLUE ISLAND PUBLIC LIBRARY  
FOR THE FISCAL YEAR  
BEGINNING JANUARY 1, 2017 AND ENDING DECEMBER 31, 2017**

**BE IT RESOLVED** by the Board of Library Trustees of the City of Blue Island, Cook County, Illinois, as follows:

**SECTION I:** Pursuant to 75 ILCS 5/3-5 and 75 ILCS 5/4-10, the following is a statement of the financial requirements of the **BLUE ISLAND PUBLIC LIBRARY** for the fiscal year beginning January 1, 2017 and ending December 31, 2017 for inclusion in the Appropriation Ordinance of the City of Blue Island, and a statement of the amount of money which has been determined in the judgment of the Board of Library Trustees to be necessary for the City of Blue Island to levy in the City's annual Tax Levy Ordinance.

**B. ITEMS TO BE LEVIED FROM A SPECIAL TAX IN ADDITION TO THE GENERAL LIBRARY TAX/CORPORATE TAX:**

A Special Tax pursuant to 75 ILCS 5/3-1 providing for the levy up to .02% of the value of all taxable property in the City of Blue Island, as equalized or assessed by the Department of Revenue, for the purchase of sites and buildings, for the construction and equipment of buildings, for the rental of buildings required for Library purposes, and maintenance, repairs, and alterations of Library buildings and equipment.

**SECTION IV:** The Library Board Secretary is hereby directed to file promptly a certified copy of this Resolution with the City of Blue Island for inclusion in the next Appropriation Ordinance and Levy Ordinance of the City of Blue Island.

**SECTION V:** Consistent with the foregoing, the Board of Library Trustees seeks inclusion in the City's Levy Ordinance a levy for Library purposes in the sum of \$1,227,461.00
