A Special Tax pursuant to 75 ILCS 5/3-1 providing for the levy up to .02% of the value of all taxable property in the City of Blue Island, as equalized or assessed by the Department of Revenue, for the purchase of sites and buildings, for the construction and equipment of buildings, for the rental of buildings required for Library purposes, and maintenance, repairs, and alterations of Library buildings and equipment.

SECTION V: Consistent with the foregoing, the Board of Library Trustees seeks inclusion in the City's Levy Ordinance a levy for Library purposes in the sum of \$1,362,248.00
