

**RESOLUTION SETTING FORTH FINANCIAL REQUIREMENTS
OF THE
BLUE ISLAND PUBLIC LIBRARY
FOR THE FISCAL YEAR
BEGINNING JANUARY 1, 2016 AND ENDING DECEMBER 31, 2016**

BE IT RESOLVED by the Board of Library Trustees of the City of Blue Island, Cook County, Illinois, as follows:

SECTION I: That, pursuant to 75 ILCS 5/4-10, the following is a statement of the financial requirements of the **BLUE ISLAND PUBLIC LIBRARY** for the Fiscal year beginning January 1, 2016 and ending December 31, 2016 for inclusion in the Appropriation Ordinance of the City of Blue Island, and a statement of the amount of money which has been determined in the judgment of the Board of Library Trustees it will be necessary for the City of Blue Island to levy in the City's annual Tax Levy Ordinance, said levy to be made pursuant to the provisions of the Illinois Municipal Code.

B. ITEMS TO BE LEVIED FROM A SPECIAL TAX IN ADDITION TO THE GENERAL LIBRARY TAX/CORPORATE TAX:

A Special Tax pursuant to 75 ILCS 5/3-1 providing for the levy up to .02% of the value of all taxable property in the City of Blue Island, as equalized or assessed by the Department of Revenue, for the purchase of sites and buildings, for the construction and equipment of buildings, for the rental of buildings required for Library purposes, and maintenance, repairs, and alterations of Library buildings and equipment.

SECTION III: That the Board of Library Trustees hereby confirms that a specific fund is established to accumulate from the unexpended balance of the proceeds received from the Library taxes said fund being accumulated and set aside as a reserve fund for the repairs and alterations of Library building and equipment in accordance with 75 ILCS 5/5-8.

SECTION IV: That the Secretary is hereby directed to file a certified copy of this Resolution with the City Council of the City of Blue Island within the time specified by law for inclusion in the next Appropriation Ordinance and Levy Ordinance of the City of Blue Island.

SECTION V: That, consistent with the foregoing, the Board of Library Trustees seeks inclusion in the City's Levy Ordinance a levy for Library purposes in the sum of \$1,260,750.


