- Paula Danoff commented that it would be helpful to have shopping protocols available for businesses and to share with shoppers specifically around waiting to shop when the weather is unfavorable – texting or Eventbrite sign up (for the Art Expo at Evanston Art Center)
 - i. CSE can share a list of ideas on shopping protocols and create messages for consumers as well to share on social media, website, etc.
- c. John Tassi suggested having retailer, restaurant committees for businesses to share resources, discuss intricacies of the business type
 - i. CSE Board can form committees retail, restaurant, marketing, governance
 - ii. Important to cross promote in the district between business types as well i.e. encourage shoppers to order takeout meals form restaurants after shopping
- d. Peter O'Malley asked about board input on the budget for some of the larger line items public way aesthetics
 - i. The 2021 budget has been approved but not specific projects for each expense category. The Board will discuss how to spend the money at future meetings, especially some of the bigger project for the district.
