- I. Mike Smylie called meeting to order at 9:07am
- II. Approval of November Minutes
 - a. Angela motioned to approve; Andrew seconded; minutes approved unanimously.
- III. Treasurer's Report: Andrew
 - a. December Financials
 - i. Tax levy payment due at the end of January; Paul noted it might be sooner
 - ii. Currently have 2.5 months of reserves left, so if the distribution is any further delayed, we will have to tap into our existing line of credit
 - b. Andy's additional updates
 - i. Adding "classes" to 2024 Chart of Accounts so that we can track revenues and expenses by individual programs
 - ii. Continuing to collect accounts receivables from outstanding invoices
 - Moved \$50k from Byline money market account to checking account to cover anticipated 2023 expenses
 - iv. 2022 audit is complete and uploaded to website
- IV. Executive Director update: Andy
 - a. Continuing to make internal updates on OneDrive file management, contact organization, etc.
 - b. Website updates are ongoing, including meetings with VibeMap to work out glitches

- g. Andy will be participating in League of Women Voters panel on Downtown Evanston economic development efforts on 1/27
- h. Exploring ways to support and collaborate with new Evanston Folk Festival on Sept 7 & 8 V. Director of Marketing update (Laura)
